



TERMS AND CONDITIONS OF SERVICE

MYWORLDCONEKTER S.A.P.I. DE C.V.

1. Terms of Acceptance

MYWORLDCONEKTER S.A.P.I. DE C.V. welcomes you to our company. MYWORLDCONEKTER SAPI DE CV provides the Services (defined below) to you subject to the following Terms of Service (“TOS”), which we may update from time to time without notice.

For access to and use of the services of MYWORLDCONEKTER S.A.P.I. DE C.V., you accept and agree to be bound by the terms and provisions of the TOS. Furthermore, when using the particular services owned by MYWORLDCONEKTER S.A.P.I. DE C.V. operated by MYWORLDCONEKTER S.A.P.I. DE C.V., you and MYWORLDCONEKTER S.A.P.I. DE C.V. shall be subject to any published guidelines, agreements, or rules applicable to such services, which may be posted and modified from time to time. The TOS incorporates all such guidelines or rules by reference. MYWORLDCONEKTER S.A.P.I. DE C.V. 2. Right to Modify

16. Termination
